### FACILITY RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to utilize the facilities, services, and programs of Columbia Street Baptist Church (CSBC) for any purpose, including, but not limited to observation or use of facilities or equipment, the undersigned, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry in CSBC for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER CSBC FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, I, for myself and as the parent and/or legal guardian of above listed, understand the nature of activities and the inherent dangers involved in such activity. I hereby release, discharge, covenant not to sue, and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS CSBC, its instructors, and employees, from any and all liability, claims, demands, losses or damages in any way related to my or my child's use of the facilities, equipment, or apparatus of CSBC. I further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Releasee, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss liability, damage, or any cost that may incur as the result of any such claim, to the fullest extent permitted by law.

#### THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE CSBC, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with CSBC.

THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of releasee or otherwise while in, about or upon the premises of CSBC and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with CSBC.

THE UNDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Maine and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
- By signing this release, I acknowledge my understanding and acceptance of the following for Rock Climbing \_\_\_\_\_\_ (Initial) that there are numerous risks and hazards inherent in the sport of climbing including but not limited to: collisions with other participants and spectators. Further, I understand that there may be other risks not known to me or reasonably foreseeable at this time. I understand that having an agent of CSBC present does not lessen the amount of severity of the risks of these activities. I understand that CSBC is not responsible for my safety and I freely and expressly assume and accept the responsibility for any and all risks of injury or death while participating in the sport of climbing.
- By signing this release, I acknowledge my understanding and acceptance of the following for Fitness and Exercise in the Gym \_\_\_\_\_\_ (Initial): I have been offered and urged to consult with my physician for a physical to determine any health risks associated with my exercising. I understand that exercise will place an increased workload on my cardio-respiratory and musculoskeletal system and there is a risk of physical changes during or following my exercise. I understand that failure to use the gym and equipment properly may result in injury, illness, or medical problems not limited to fractured or broken bones, strained or torn muscles, tendons, or ligaments, dizziness, feeling light headed or becoming faint, stroke, heart attack, joint problems or other physical problems. I understand I am responsible for monitoring my own condition throughout the exercise program and should any unusual symptoms occur, I will cease my participation and inform the instructor or CSBC agent. I certify I have no physical condition which prevents me from safely engaging in an exercise program and agree to abide by all rules and regulations of CSBC.

I have read the Release of Liability for Personal Injury and have been given the opportunity to speak with a representative of CSBC before signing this release. I acknowledge and consent to CSBC taking photographs and/or videos that may be used for promotional purposes.
